WHEREAS, the Federal Aid Highway Act of 1973 provides for federal participation in the funding of both highway projects and transit projects under the Federal Aid Urban Program; and

WHEREAS, the Act restricts the term "transit project" to the purchase of buses or the construction of a fixed rail system including the purchase of rolling stock for a fixed rail system; and

WHEREAS, the Act includes under the category of "highway project" such transit support facilities as passenger shelters, bus passenger loading areas, fringe or corridor parking facilities, and exclusive bus lanes; and

WHEREAS, over the three fiscal years for which Congress has authorized the appropriation of funds for the Federal Aid Urban Program, that period ending June 30, 1976, the short term transportation needs of The City of San Diego require a reasonable allocation of Federal Aid Urban funds between highway projects and transit projects; and

WHEREAS, the County Board of Supervisors, designated as the appropriate local officials charged with administering the Federal Aid Urban Program for the urbanized area of San Diego County has requested The City of San Diego to indicate its desires as to the proportion of Federal Aid Urban funds to be allocated to "transit projects" as defined herein; and

WHEREAS, the Federal Aid Highway Act of 1973 restricts the use of Federal Aid Urban funds for "transit projects" to fiscal years 1974-75 and 1975-76; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager is hereby authorized to notify the County Board of Supervisors that it is the recommendation of this Council that from the funds allocated to the urbanized area of San Diego County under the Federal Aid Urban Program in each of the fiscal years 1974-75 and 1975-76, the following proportions be available for the funding of "transit projects" as defined by the Federal Aid Highway Act of 1973: (a) 25% for fiscal year 1974-75; and (b) 50% for fiscal year 1975-76.
