STELL, Registered Civil Engineer, and entitled "CERCA DE LA PLAYA Being a subdivision of portions of Pueblo Lots 1280 and 1297 of the Pueblo Lands of San Diego, in the City of San Diego, County of San Diego, State of California, according to Map thereof made by James Pascoe in 1870, a copy of which said map was filed in the office of County Recorder of San Diego County, November 14, 1921 and is known as Miscellaneous Map No. 36.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Calle De La Garza and a portion of Calle Del Cielo, for public purposes, and said street and portion of street are hereby declared to be a public street and a portion of a public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer facilities, as granted and shown on said map and subject to the conditions set forth thereon.


