

RESOLUTION OF INTENTION NO. 210666 MAY 23 1974

A RESOLUTION ELECTING TO PROCEED UNDER THE PROVISIONS OF THE STREET VACATION ACT OF 1941, DECLARING THE INTENTION OF THE CITY COUNCIL TO VACATE DOUGLASS STREET WEST OF THE SOUTHERLY PROLONGATION OF THE EAST LINE OF LOT 12, BLOCK 63, ARNOLD & CHOATE'S ADDITION; INGALLS STREET BETWEEN WASHINGTON STREET AND WASHINGTON PLACE; AND A PORTION OF WASHINGTON PLACE BETWEEN THE WEST LINE OF ARNOLD & CHOATE'S ADDITION AND THE WEST LINE OF LOT 24, BLOCK 62, ARNOLD & CHOATE'S ADDITION, AND FIXING A TIME AND PLACE FOR HEARING THEREOF.

BE IT RESOLVED, by the Council of The City of San Diego, that the public interest and convenience of said City require the vacation of the streets hereinafter mentioned; and in connection therewith require the reservation of sewer and drainage easements in the area covered by such streets.

BE IT FURTHER RESOLVED, that it is the intention of said Council to order the vacation of DOUGLASS STREET west of the southerly prolongation of the east line of Lot 12, Block 63, Arnold & Choate's Addition; INGALLS STREET between Washington Street and Washington Place; and a portion of WASHINGTON PLACE between the west line of Arnold & Choate's Addition and the west line of Lot 24, Block 62, Arnold & Choate's Addition, as more particularly shown on Map Nos. 13131-1-B and 13131-2-B, on file in the office of the City Clerk as Document No. 747399.

The Council hereby elects to proceed, in making said vacation, under the provisions of the "Street Vacation Act of 1941."


