A RESOLUTION ELECTING TO PROCEED UNDER THE PROVISIONS OF THE STREET VACATION ACT OF 1941, DECLARING THE INTENTION OF THE CITY COUNCIL TO VACATE ZOLA STREET BETWEEN CLOVE STREET AND CHATSWORTH BOULEVARD AND FIXING A TIME AND PLACE FOR HEARING THEREOF.

Dail Concourse, 202 C Street, in said City of San Diego, as the time and place for hearing all persons interested in or objecting to the proposed vacation.

That The Daily Transcript, a daily newspaper published and circulated, and of general circulation, in the said City of San Diego, be, and it is hereby designated as the newspaper in which the Street Superintendent of said City shall cause to be published, in the manner and form required by law, notice of the passage of
