
Adopted on MAY 23 1974

That the acceptance by the City Manager of that deed of THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO, executed in favor of The City of San Diego, bearing date of April 18, 1974, conveying to said City portions of Lots E and F, Block 184, portions of Lots A through F, inclusive, Block 2, and portions of Lots D through F, Block 25, all of Horton's Addition, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named TWELFTH AVENUE.

BE IT FURTHER RESOLVED, that the City Clerk of said City is hereby authorized and directed to file the foregoing said deed in the office of the Recorder of San Diego County.
