

**RESOLUTION No. 210670**Adopted on MAY 23 1974


BE IT RESOLVED, by the Council of The City of San Diego as follows:

Roark, et al., vs. Jno F. Forward, et al.", for park and recreation purposes, be, and the same is hereby approved.

BE IT FURTHER RESOLVED, that the expenditure of \$14,500 is hereby authorized from San Diego Park District No. 3 Fund 3711 solely and exclusively to provide funds for the acquisition of land for park and recreation purposes as stated above.

BE IT FURTHER RESOLVED, that the City Clerk of said City be and he is hereby directed to deliver said deed to the Property Director of The City of San Diego for further handling.
