

**RESOLUTION No. 210672**Adopted on MAY 23 1974


BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of WAYNE D. STEIMLE and LORENE H. STEIMLE, husband and wife as joint tenants, executed in favor of The City of San Diego, bearing date of March 15, 1974, conveying to said City Lots 1 and 2, Block 51 of Middleton Addition, for park and recreation purposes, and their easement interests in a portion of Lot 3 in Block 51 of Middletown Addition, all as more particularly described in said deed, be, and the same is hereby approved.

BE IT FURTHER RESOLVED, that the expenditure of \$12,900 is hereby authorized from San Diego Park District No. 3 Fund 3711 solely and exclusively to provide funds for the acquisition of land for park and recreation purposes as stated above.

BE IT FURTHER RESOLVED, that the City Clerk of said City be and he is hereby directed to deliver said deed to the Property Director of The City of San Diego for further handling.
