WHEREAS, the Planning Commission of The City of San Diego has recommended approval of said name changes; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That FLAT CAR STREET, for its entire length, be and the same is hereby renamed TRADE STREET, as more particularly shown and described in Drawing No. 13351-B, on file in the office of the City Clerk as Document No. 747492 which shall govern as to all details therein.

2. That CABOOSE AVENUE, for its entire length, be and the same is hereby renamed CARROLL WAY, as more particularly shown and described in Drawing No. 13351-B, on file in the office of the City Clerk as Document No. 747492 which shall govern as to all details therein.

BE IT FURTHER RESOLVED, that the City Clerk of said City be and he is hereby directed to file a certified copy of this resolution in the offices of the County Clerk, County Recorder and County Surveyor of San Diego County.
