RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO, CALIFORNIA, DETERMINING FEASIBILITY AND APPROVING PLANS AND PROFILES SHOWING CHANGES AND MODIFICATIONS IN THE WORK DESCRIBED IN RESOLUTION OF INTENTION NO. 210350 FOR THE IMPROVEMENT OF THE ALLEYS IN BLOCKS 1 AND 10, SILVER TERRACE; ALLEY IN BLOCK D, SILVER TERRACE ADDITION, AND THE ALLEYS IN BLOCK 16, MISSION BAY TRACT.

WHEREAS, the hearings provided for in Resolution of Intention No. 210350 have been held at the time and place fixed, and all continuances, if any, were duly made and ordered; and

WHEREAS, at said hearings all persons desiring to be heard were fully heard and all oral and written protests and objections, if any, were fully considered and this Council gave all persons present an opportunity to hear and be heard in respect to the proposed improvement; and

WHEREAS, this City Council did on April 11, 1974, adopt the Resolution of Intention No. 210350 and declare its intention to order the construction of certain improvements as more fully described therein and on the plans, profiles and drawings therein referred to, and did provide for the cost of certain work to be assessed against the district described in said Resolution of Intention; and

WHEREAS, the public interest, convenience and necessity require that the sewer mains be deleted from the proposed work to be done in said Resolution of Intention; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. Written protest or objection against the proposed improvements has not been made by the owners of more than one-half of the area of the land included within the assessment district or of the area of property to be assessed. Each and all oral and written protests and objections, if any, made or filed in the matter are hereby overruled and denied.

2. The proposed improvements within the limits mentioned in Resolution of Intention No. 210350 are hereby determined to be feasible and that the lands to be assessed therefor will be able to carry the burden of such proposed assessment, and that the public convenience and necessity require the proposed improvements, and that the Special Assessment Investigation, Limitation and Majority Protest Act of 1931 shall not apply.

3. That the plans, drawings, typical cross-sections, profiles and specifications for the improvement of the ALLEYS IN BLOCKS 1 AND 10, SILVER TERRACE; ALLEY IN BLOCK D, SILVER TERRACE ADDITION, AND THE ALLEYS IN BLOCK 16, MISSION BAY TRACT, heretofore filed in the office of the City Clerk as Document No. 746890 and approved by Resolution No. 210349, be and the same are amended to conform with City of San Diego Engineering Department Drawings, filed in the office of the City Clerk as Document No. 747703, and the same are hereby approved and adopted as the official drawings, typical cross-sections, profiles and specifications for said work and improvements.
