


RESOLUTION No. 210693

That the City Manager be, and he is hereby authorized and empowered, for and on behalf of said City, to submit an amended UMTA Capital Grant CA-02-0081 in the amount of \$2,765,815 to the United States Department of Transportation, Urban Mass Transportation Administration, incorporating the purchase of thirty (30) additional 19 to 22 passenger buses, ninety-one (91) additional registering fareboxes, thirty (30) additional two-way radios, and other minor changes, pursuant to the terms and conditions set forth in the form of amended application on file in the office of the City Clerk as Document No. 747484.
