

1. That the bid of \$39,100.00 by Patrick J. Timmins, an Individual, dba Patrick J. Timmins for CENTRAL OPERATIONS STATION CONSTRUCTION OF MEZZANINE STORAGE FLOOR FOR PLUMBING SHOP AND PREFABRICATED STORAGE BUILDING, SCHEDULE III AND SCHEDULE IV in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 746446.
2.
