
**RESOLUTION No. 210700**

Adopted on MAY 30 1974

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bids of A. Carl Burger Dodge B. International Harvester C. University Ford are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of THIRTY-SEVEN (37) VEHICLES as follows:
  - A. Carl Burger Dodge, for Group SS-3055, one (1) intermediate sedan for \$3,648.02, Group LT-210, two (2) 5,000 GW Cab & Chassis at \$2,889.46 each, Group LT-215, one (1) 5,600 lb. GW pickup for a cost of \$4,111.11, Group LT-220, two (2) 7,500 lb. GW pickups at \$3,373.71 each, two (2) 7,500 lb. Cab & Chassis at \$3,201.06 each, Group LT-221, five (5) 7,500 lb. GW vans at \$3,785.49 each, Group LT-230, fourteen (14) 10,000 lb. Cab & Chassis at \$3,223.10 each, for a total cost of \$90,738.44, terms net 30 days plus sales tax.
  - B. International Harvester, for Group LT-201, two (2)  $\frac{1}{4}$ -ton four wheel drive vehicles at a unit cost of \$4,069.51 each, Group LT-216, one (1) 6,600 lb. GW four wheel drive Travellall at a unit cost of \$4,951.23, for a total cost of \$13,090.25, terms net 30 days plus sales tax.
  - C. University Ford, for Group CS-3005, seven (7) sub-compact two-door sedans, at \$2,534.55 each for a total cost of \$17,741.85, terms net 30 days plus sales tax.
2. That all bids theretofore received on April 25, 1974, pursuant to publication of notice calling for bids on furnishing Group LT-205 (Sixty (60) compact pickups) are hereby rejected.
