


**RESOLUTION No. 210719**

Adopted on MAY 30 1974

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a Consent to Sublease Agreement whereby City consents to its Lessee HOUSE OF HOSPITALITY ASSOCIATION, INC., under lease agreement on file in the office of the City Clerk as Document No. 710524, subleasing a portion of its lease premises to JOHN COX and SUSAN STEPHENS COX and LELAND FEATHERMAN and CAROLYN SUE FEATHERMAN for the purpose of operating and maintaining a restaurant with the right to sell alcoholic beverages on said subleased premises, known as Cafe Del Rey Moro, wherein House of Hospitality Association, Inc. receives a minimum of \$500 per month, for a term of 38 months commencing February 5, 1974, under the terms and conditions set forth in the form of Consent to Sublease Agreement on file in the office of the City Clerk as Document No. 747470.
