

RESOLUTION NO. 210735

**MAY 30 1974**

WHEREAS, the Council of The City of San Diego by Resolution No. 209364 adopted a Deferred Compensation Plan for certain eligible employees of the City; and

WHEREAS, the Council has directed the Management Team to meet and confer in respect to eligibility for participation in said Plan; and

WHEREAS, the Management Team has, pursuant to direction of the City Council, met and conferred in relation to eligibility for participation in said Deferred Compensation Plan and has reached agreement with several employee organizations thereon; and

WHEREAS, the Management Team has recommended to this Council that those employee organizations reaching memoranda of agreement with the City in respect to participation be permitted to participate in said Plan; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that paragraph II, subparagraph B of The City of San Diego Employees' Deferred Compensation Plan, adopted by Resolution No. 209364, on file in the office of the City Clerk as Document No. 745636, be and the same is hereby amended to read as follows:

"II. DEFINITIONS:

B. "Participant" means any of the following who elect to defer a portion of their compensation under this Plan:

1. All elected legislative officials;
2. All full-time unclassified officers and employees;
3. All full-time classified officers and employees not represented by any formally recognized employee organization; and
4. All full-time officers and employees in formally recognized units represented by the following employee organizations:
  - a. San Diego Municipal Employees Association;
  - b. Local 127, AFSCME, AFL-CIO;
  - c. San Diego Police Officers Association, Inc.; and
  - d. San Diego Fire Fighters, Local 145, AFL-CIO."
