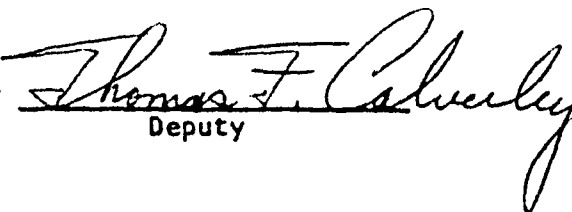
BE IT RESOLVED, by the Council of The City of San Diego as follows:

2. KMT Corporation c/o Jewett Company, for Items 4,6,7,11 and 12, for a cost of \$11,078.00, terms net 30 days plus sales tax plus estimated freight charges of \$35.00, with an option to purchase additional equipment at the stated prices and conditions for 12 months from the time the first purchase order is issued.
