

RESOLUTION OF INTENTION NO. 210766

JUN 6 1974

A RESOLUTION ELECTING TO PROCEED UNDER THE PROVISIONS OF THE STREET VACATION ACT OF 1941, DECLARING THE INTENTION OF THE CITY COUNCIL TO VACATE PITTSBURGH AVENUE BETWEEN THE WESTERLY LINE OF LOT 29, ENCANTO, AND LOT 23, W. A. SHAULES CO. SUBDIVISION; AND LEONARD STREET ADJACENT TO LOT 62, W. A. SHAULES CO. SUBDIVISION AND FIXING A TIME AND PLACE FOR HEARING THEREOF.

BE IT RESOLVED, by the Council of The City of San Diego, that the public interest and convenience of said City require the vacation of the streets hereinafter mentioned; and

BE IT FURTHER RESOLVED, that it is the intention of said Council to order the vacation of PITTSBURGH AVENUE between the westerly line of Lot 29, Encanto and Lot 23, W. A. Shaules Co. Subdivision; and LEONARD STREET adjacent to Lot 62, W. A. Shaules Co. Subdivision, as more particularly shown on Drawing No. 15957-D, on file in the office of the City Clerk as Document No. 747487.

The Council hereby elects to proceed, in making said vacation, under the provisions of the "Street Vacation Act of 1941."



Dail Concourse, 202 C Street, in said City of San Diego, as the time and place for hearing all persons interested in or objecting to the proposed vacation.
