That the City Manager be and he is hereby authorized to execute, for and on behalf of said City, a License Agreement with the ATCHISON, TOPEKA AND SANTA FE RAILWAY COMPANY for the installation of a 60" sewer pipeline in connection with the Chollas Creek Sewer Project, under the terms and conditions set forth in the form of License Agreement on file in the office of the City Clerk as Document No. 747681.

BE IT FURTHER RESOLVED, that the expenditure of \$150 from Sewer Revenue Fund 506 is hereby authorized solely and exclusively to provide funds for said License Agreement.
