

RESOLUTION No. 210777

Adopted on JUN - 6 1974

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the City Manager be and he is hereby authorized and empowered to do by City Forces all necessary work in conjunction with the preparation of the Montgomery Field Canyon site for use as a demolition landfill, pursuant to the recommendation of the City Manager and the submission of his estimates indicating that said work can be done more economically by City Forces than if let by contract.

2. That the expenditure of \$15,000 from Federal Revenue Sharing Fund 2381 of The City of San Diego is hereby authorized solely and exclusively for the purpose of providing funds for materials and utility services for the above-referenced project.

3. That it be and it is hereby certified that the information contained in the environmental impact report on file in the office of the City Clerk as E.Q.D. No. 73-4-022C has been completed in compliance with the California Environmental Quality Act of 1970 and the State guidelines pursuant thereto, and that said environmental impact report has been reviewed and considered by this Council.
