1. That the City Manager be and he is hereby directed to schedule and implement a refuse collection service on a twice-weekly basis in Mission Beach; said schedule to be in effect from June 1 to September 30, each year.

2. That Resolution No. 200443, adopted on July 30, 1970, is hereby rescinded insofar as it relates to Mission Beach during the period from June 1 to September 30, of each year; all other provisions of Resolution No. 200443 to remain in full force and effect.
