WHEREAS, these improvements are being installed in accordance with the criteria of the City and the College District and with the approval of the Redevelopment Agency; and

WHEREAS, an agreement between the City and the Community College District is required to clearly stipulate the responsibilities, financial and otherwise, of each party in reference to the operation, maintenance, repair, replacement and ownership of the various improvements; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an Agreement with the COMMUNITY COLLEGE DISTRICT, providing for the maintenance, replacement, operation and ownership of improvements installed on the City College campus and above the B Street right-of-way, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 747705.
