RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO, CALIFORNIA, DECLARING THAT CERTAIN CITY-OWNED LANDS SHALL BE HELD, USED AND TREATED AS LANDS ACQUIRED FOR PARK PURPOSES

(Park District No. 12F - TECOLOTE CANYON)

WHEREAS, on April 20, 1971, the Council adopted Resolution No. 202455 initiating proceedings pursuant to the provisions of the San Diego Park District Procedural Ordinance of 1969, as amended, for the acquisition of open space lands for park and recreation purposes in the Tecolote Canyon area of the City of San Diego; and

WHEREAS, the City owns or is in the process of acquiring certain lands contiguous to the lands proposed to be acquired in said proceedings (all of which lands shall in these proceedings be hereafter referred to as "City-owned lands"), which lands are and shall be available and have value for park and recreation purposes; and

WHEREAS, the Council deems it advisable and in the public interest to contribute said City-owned lands to the project by declaring that they shall be held, used and treated the same as lands acquired from the acquisition and improvement fund of the proposed district, following acquisition by the City of the lands ordered to be acquired, which contribution shall constitute a part of the total contribution by the City to the project; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

Section 1. The Council hereby declares that the City-owned lands hereinafter described shall, after the acquisition by the City of all lands ordered to be acquired in connection with the proceedings hereinafter to be taken, for all purposes be held, used and treated the same as said lands acquired from the acquisition and improvement fund of the district to be established in said proceedings.

Section 2. The City-owned lands to be so held, used and treated, are more particularly described in Exhibit "A" attached to this resolution and hereby incorporated by reference herein. (City Drawings No. 16249-1-D and No. 16249-2-D)

Section 3. Subject to such proceedings as the Council may hereafter take with respect to contributing said lands without compensation as a part of the City's contribution to the project, the Council hereby declares that the value of said City-owned lands is as follows: \$1,743,000.

Section 4. This resolution is adopted, and the actions contemplated herein are and shall be taken pursuant to the provisions of Section 61.0794 of the San Diego Municipal Code.
