Johnson, an Individual, for FORMAL GARDEN IN BALBOA PARK in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the specifications on file in the office of the City Clerk as Document No. 746576.
- 2. That the expenditure of \$71,500.00 is hereby authorized out of the Park and Recreation Bond Fund (Fund No. 725) of the City of San Diego solely and exclusively for the purpose of providing funds for FORMAL GARDEN IN BALBOA PARK in the City of San Diego, and related costs.
- 3. That the donation of \$43,000.00 from the Parker Foundation to be used for the above purpose is hereby accepted.
- 4. That FORMAL GARDEN IN BALBOA PARK be, and the same is hereby officially designated as the Inez Parker Memorial Garden.
- 5. That the City Manager be, and he is hereby authorized and empowered, for and on behalf of said City, to program the second phase development of the construction of FORMAL GARDEN IN BALBOA PARK which will be officially designated as the Inez Parker Memorial Garden within the six-year Capital Improvements Program.
