


RESOLUTION No. 210823Adopted on JUN 13 1974

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That an easement for the purpose of a right of way for a public street and appurtenances thereto through, over, under, along and across a portion of Pueblo Lot 1347 of the Pueblo Lands of San Diego according to Map thereof made by James Pascoe in 1870, a copy of which Map was filed in the office of the County Recorder of said County, November 14, 1921, as more particularly described in the legal description attached hereto and incorporated herein, be and the same is hereby set aside for such public purposes; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named BOUNDARY STREET.

That the City Clerk of said City is hereby authorized and directed to file the foregoing document for record in the office of the Recorder of San Diego County.

LEGAL DESCRIPTION

All that portion of Pueblo Lot 1347 of the Pueblo Lands of San Diego according to map thereof made by James Pascoe in 1870, a copy of which map was filed in the Office of the County Recorder of said County of San Diego November 14, 1921, as Miscellaneous Map No. 36, lying Southeasterly, Easterly and Northeasterly of the following described line:

Beginning at a point in the North line of Market Street as said Market Street is located and established as of the date of this instrument, said point being located North 88°33'43" West, 70.00 feet from the Easterly boundary of said Pueblo Lot 1347; thence North 59°42'51" East, 38.10 feet; thence North 15°43'48" West, 656.42 feet; thence South 88°33'43" East, 10.47 feet; thence North 15°43'48" West, 701.68 feet; thence South 88°33'43" East, 20.93 feet to a point of terminus in the Easterly boundary of said Pueblo Lot 1347.
