

RESOLUTION No. 210825Adopted on JUN 13 1974

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That an easement for the purpose of a right of way for a public street and appurtenances thereto through, over, under, along and across a portion of Lot 1, according to License Survey No. 33 filed May 23, 1893, in the office of the Recorder of San Diego County, as more particularly described in the legal description attached hereto and incorporated herein, be and the same is hereby set aside for such public purposes; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named ULRIC STREET.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to file a certified copy of this resolution in the office of the County Recorder of San Diego County.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized and directed to transfer \$100 from Gas Tax Fund 220 to the Water Revenue Fund 500, solely and exclusively for right-of-way for Ulric Street.

LEGAL DESCRIPTION OF CITY-OWNED
PROPERTY TO BE SET ASIDE, DEDICATED,
AND NAMED ULRIC STREET

All that portion of Lot 1, according to License Survey No. 33 filed May 23, 1893, in the Office of the Recorder of San Diego County, said License Survey No. 33 being a subdivision of the North 80 acres of Pueblo Lot 1175 of the Pueblo Lands of the City of San Diego according to the Map thereof made by James Pascoe in the year 1870, a copy of which is filed in said County Recorder's Office November 14, 1921, and known as Miscellaneous Map No. 36, being also that portion of land described in Deed from The United States of America to the City of San Diego dated May 31, 1957, and recorded July 1, 1957 as Document No. 97603 in Book 6643, Page 486 of Official Records of the County Recorder of San Diego County; more particularly described as follows:

Beginning at the most Easterly corner of said land conveyed to the City of San Diego by Deed recorded July 1, 1957 in Book 6643, Page 486 of Official Records of the County Recorder of San Diego County being also a point on the arc of a 640.00 foot radius curve, (Record 640.90 foot radius curve per said Deed) concave Easterly; thence Northerly along the Easterly line of said Land conveyed to the City of San Diego and along the arc of said curve through a central angle of $10^{\circ}38'30''$ and arc length of 118.85 feet (Record $08^{\circ}34'58''$ and arc length of 96.00 feet per said Deed); thence tangent to said curve and continuing along the Easterly line of said land conveyed to the City of San Diego North $11^{\circ}58'55''$ West, 94.59 feet (Record North $11^{\circ}57'45''$ West, 117.00 feet per said Deed); thence leaving said Easterly line of said land conveyed to the City of San Diego and proceeding along the Northerly line of said land conveyed to the City of San Diego South $71^{\circ}45'57''$ West (Record South $71^{\circ}37'24''$ West per said Deed), 11.07 feet; thence leaving said Northerly line South $11^{\circ}58'55''$ East, 97.87 feet to a point on the arc of a tangent 663.00 foot radius curve, concave Easterly; thence Southerly along the arc of said curve through a central angle of $09^{\circ}49'21''$ an arc length of 113.66 feet to the Southerly line of said land conveyed to the City of San Diego; thence along said Southerly line North $80^{\circ}47'00''$ East (Record North $80^{\circ}43'40''$ East per said Deed) returning to the most Easterly corner of said land conveyed to the City of San Diego and the Point of Beginning.
