


RESOLUTION No. 210834

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered, for and on behalf of said City, to: (1) accept from the ACTION Agency a grant of \$176,000 for the implementation of the Program for Local Service (PLS) in the City of San Diego and environs; (2) encumber \$117,000 of funds in the Human Resources Department FY75 Youth Employment Program budget to be used as the required local match for the ACTION grant; and, (3) hire personnel as necessary to carry out the designated program.
