That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an Agreement with the REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO for the purpose of installing a storm drain from "C" Street to Broadway, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 747731.

BE IT FURTHER RESOLVED, that the Auditor of said City be and he is hereby authorized to transfer to the Redevelopment Agency of the City of San Diego (City College Redevelopment Project Fund No. 9834) the sum of \$17,000 from Capital Outlay Fund 245 Reserve to be used for the design and construction of said improvements.
