
VACATION OF IRONWOOD ROAD SOUTHWESTERLY OF SCRIPPS

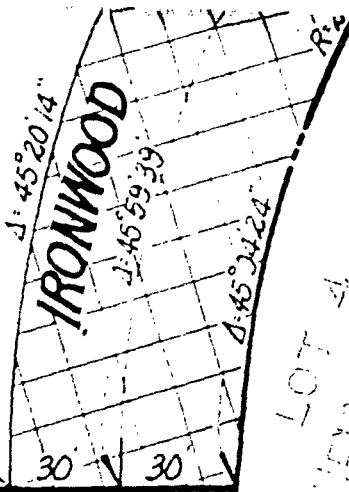



