A RESOLUTION ELECTING TO PROCEED UNDER THE PROVISIONS OF THE STREET VACATION ACT OF 1941, DECLARING THE INTENTION OF THE CITY COUNCIL TO VACATE A PORTION OF A STREET RESERVATION IN LOT 1, RANCHO CASTER, AND FIXING A TIME AND PLACE FOR HEARING THEREOF.
