

RESOLUTION NO. 210901**JUN 20 1974**

VACATION OF WITHERBY STREET AND COUTS STREET  
BETWEEN SAN DIEGO AVENUE AND INTERSTATE 5.

BE IT RESOLVED, by the Council of The City of San Diego, California, that WITHERBY STREET and COUTS STREET between San Diego Avenue and Interstate 5, as more particularly referred to in Resolution of Intention No. 210667 are unnecessary for present or prospective public street purposes.

BE IT FURTHER RESOLVED, that the public interest, convenience and necessity of said City requires the reservation of public easements, as more particularly referred to in Resolution of Intention No. 210667.

BE IT FURTHER RESOLVED, that WITHERBY STREET and COUTS STREET between San Diego Avenue and Interstate 5, as more particularly shown on Map No. 13044-B on file in the office of the City Clerk as Document No. 747400, which said map is attached hereto and made a part hereof, be, and the same are hereby vacated.

BE IT FURTHER RESOLVED, that The City of San Diego reserves and excepts from the foregoing vacation the permanent easements as more particularly described hereinafter:

Reserving and excepting to The City of San Diego the right, easement and privilege of placing, constructing, repairing, replacing, maintaining, using and operating public utilities of

any kind or nature, including, but not limited to sewer, water, drainage, and all necessary and proper fixtures and equipment for use in connection therewith, through, over, under, upon, along and across the hereinafter described easement, together with the right of ingress thereto and egress therefrom, together with the right to maintain the said easement free and clear of any excavation or fills, the erection or construction of any building or other structures, the planting of any tree or trees thereon, or the drilling or digging of any well or wells thereon, together with the right to otherwise protect from all hazards the operation and use of any right hereby reserved. Upon written permission of the City, the owners of the underlying fee may utilize the above described parcel of land for structures, the planting or growing of trees or the installation of privately owned pipelines.

The easements reserved herein are in, under, over, upon, along and across portions of Coutts Street and Witherby Street vacated by this document and as they are more particularly shown on said Map No. 13044-B on file in the office of the City Clerk as Document No. 747400.

BE IT FURTHER RESOLVED, that the City Clerk shall cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.

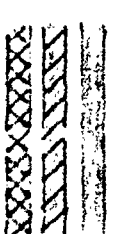

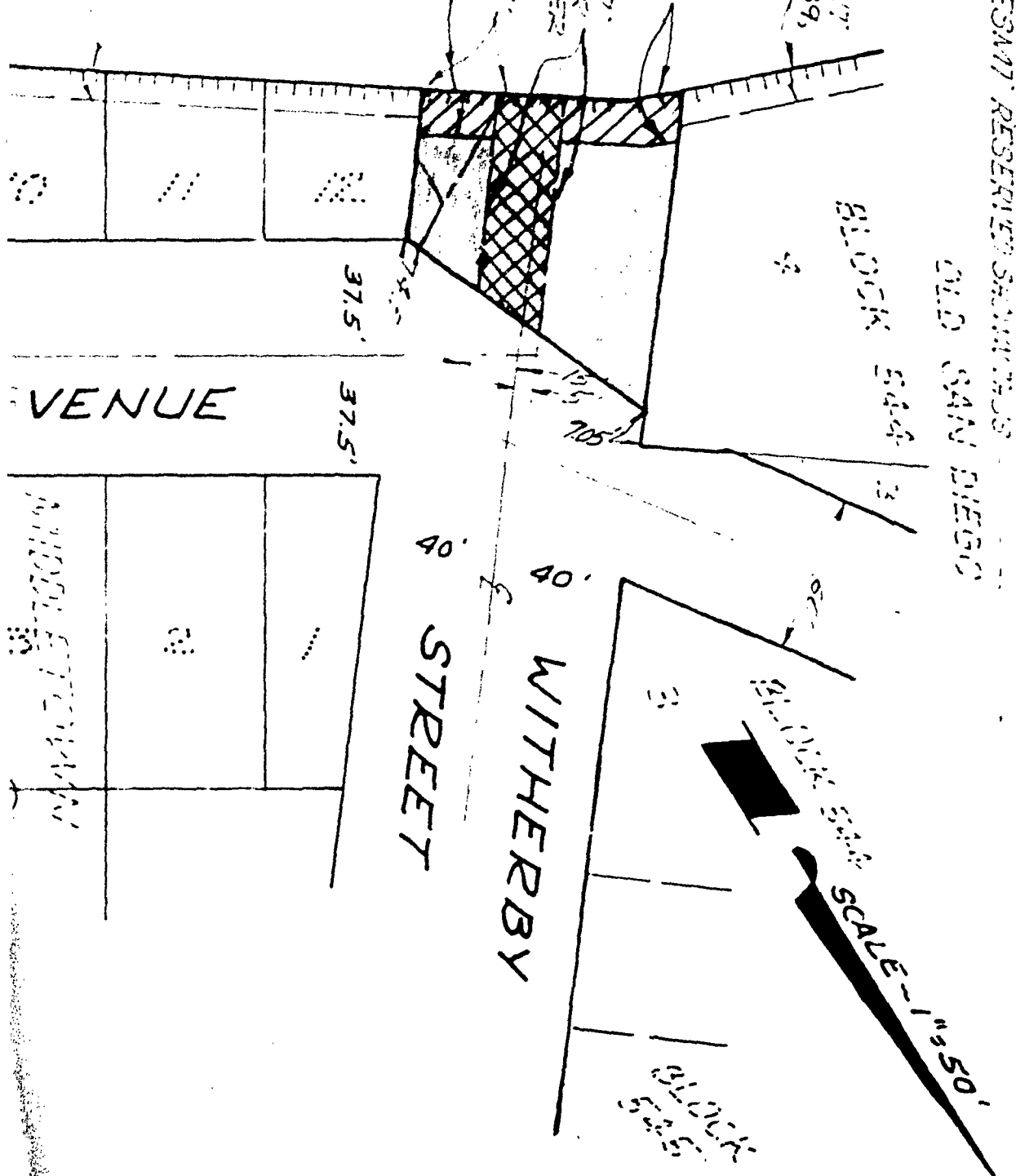
