

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bid of The Flintkote Co., U.S. Lime Div. is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of BULK QUICKLIME as may be required for a period of one (1) year beginning July 1, 1974 through June 30, 1975, at a cost of \$30.00 per ton; terms, \$0.25 per ton 30 days, plus sales tax on 5% of material, plus a freight charge of \$10.094 per ton; and an escalation clause granting three price increases for material and/or freight, with each increase not to exceed 17% of bid prices.
