

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. Consolidated Electrical Distributors 2. Graybar Electric Co. 3. Westinghouse Elect. Supply Co. and 4. Sunlight Electric Supply Co., Inc. are hereby accepted, and the City Manager is hereby authorized to execute contracts for the purchase of ELECTRICAL MAINTENANCE AND REPAIR MATERIALS as may be required for a period of one (1) year beginning July 1, 1974 through June 30, 1975 per prices and escalation clauses on file in the Purchasing Department as follows:

1. Consolidated Electrical Distributors for Sections 1 and 2; terms 2% 15 days, plus sales tax, and;
2. Graybar Electric Co. for Section 3; terms 2% 10 days, plus sales tax, and;
3. Westinghouse Elect. Supply Co. for Section 4; terms 2% 30 days, plus sales tax, and;
4. Sunlight Electric Supply Co., Inc. for Section 5; terms 2% 20 days, plus sales tax.
