


**RESOLUTION No. 210954**Adopted on JUL 5 1974

That the acceptance by the City Manager of that deed of JOHN A. WATERS and EILEEN R. WATERS, husband and wife as joint tenants, as to an undivided 1/2 interest, and ANTHONY K. MASON and ALICE S. MASON, husband and wife as joint tenants, as to an undivided 1/2 interest, executed in favor of The City of San Diego, bearing date of May 2, 1974, conveying to said City an easement for a right of way for a public alley and incidents thereto, affecting a portion of Lot 27 of La Jolla Soledad, according to Map thereof No. 4678, as more particularly described in said deed, be and the same is hereby approved, and the land therein conveyed is hereby dedicated as and for a public alley.

That the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
