

RESOLUTION No. 210955Adopted on JUL 5 1974

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of VISTA VIEW DEVELOPMENTS, INC., a California corporation, executed in favor of The City of San Diego, bearing date of April 18, 1974, conveying to said City an easement for a right of way for a public alley and incidents thereto, affecting portions of Parcels 1 through 3 according to Parcel Map thereof No. 1957, filed in the San Diego County Recorder's Office, portions of Lots 203 to 207, Soledad Corona Estates Unit No. 3 according to Map thereof No. 4473, and a portion of Lot 43 of La Jolla Pacifica, Unit No. 1 according to Map thereof No. 4787, all as more particularly described in said deed, be and the same is hereby approved, and the land therein conveyed is hereby dedicated as and for a public alley.

That the City Clerk of said City is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
