

That having filed an application for two Limited Certificates of Public Convenience and Necessity to operate taxicabs pursuant to the provisions of Section 72.01 of the San Diego Municipal Code, and the City Manager having conducted the required investigation, the City Council hereby grants two Limited Certificates of Public Convenience and Necessity limited to a one-year period and the pickup areas of Rancho Bernardo and Rancho Penasquitos as indicated on the attached map to Poway Cab Company to operate the vehicles specified in the application.
