That the expenditure of \$125,800 from San Diego Park District No. 4, Fund 3712, is hereby authorized solely and exclusively to provide funds for the purchase of the above described property.

That the City Clerk is hereby authorized and directed to transmit the foregoing said deed and a certified copy of this resolution to the Property Director of The City of San Diego for further handling.
