That the City Manager be, and he is hereby authorized and empowered to execute for, and on behalf of said City, an agreement with BANK OF AMERICA, NATIONAL TRUST AND SAVINGS ASSOCIATION, authorizing Bank of America to act as agent for The City of San Diego for the payment and redemption of Municipal Bonds and interest coupons, and for the destruction of Municipal Bonds and coupons, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 748242.
