It had been necessary for officers at the Northern Division to bring suspects to the Central Station to be given an examination. It was proposed that the examiners be scheduled at the Northern Station two or more days a week. This has been done for a substantial saving in the time of investigating officers and vehicle mileage. Estimated savings are \$1,645, but as this program has been in effect nearly a year, indicated savings will be higher. Actual savings will be determined at the end of the first year, and additional award made if warranted.
