

1. That the bid of \$69,796.00 by Melvin S. Williamson Jr., an Individual, dba Mel Williamson Construction for the CONSTRUCTION OF IMPROVEMENTS TO FEDERAL BUILDING AND GYMNASIUM BALBOA PARK in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 747141.
2.
