BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the expenditure of \$2,000 from Capital Outlay Fund 245 of The City of San Diego is hereby authorized solely and exclusively for the purpose of providing funds for the installation of two ornamental safety lights on Dewey Street at National Avenue, and on Dewey Street at Logan Avenue.

BE IT FURTHER RESOLVED, that the City Manager be, and he is hereby authorized and empowered to do by City Forces all necessary work in conjunction with the above referenced project of installing said ornamental safety lights, pursuant to the recommendation of the City Manager and the submission of his estimates indicating that said work can be done more economically by City Forces than if let by contract.
