BE IT RESOLVED, by the Council of The City of San Diego as follows:

Pursuant to authority conferred by and in accordance with the provisions of Section 86.06 of the San Diego Municipal Code, the PARKING OF VEHICLES IS HEREBY PROHIBITED twenty-four hours a day, seven days per week, on and along the following street in said City:

North side of MONTEZUMA ROAD, between
Campanile Drive and El Cajon Boulevard.

BE IT FURTHER RESOLVED, that the installation of the necessary signs and markings be and the same are hereby authorized and directed to be made on said street, and that the regulations hereinabove imposed shall become effective upon the installation of such signs.

BE IT FURTHER RESOLVED, that the expenditure of \$8,000 is hereby authorized out of Gas Tax Fund 220 of The City of San Diego, solely and exclusively for the purpose of providing funds to slurry seal Montezuma Road within the limits described above, supplementing Resolution No. 206608 in this amount.
