That the acceptance by the City Manager of that deed of BOARD OF ADMINISTRATION, THE SAN DIEGO CITY EMPLOYEES' RETIREMENT SYSTEM, executed in favor of The City of San Diego, bearing date of May 29, 1974, conveying to said City Lots H, I, J and portion of Lot G in Block 51, and Lots A, B and C, Block 52, all of Horton's Addition, in the City of San Diego, as more particularly described in said deed, valued at \$500 or more as certified by the Property Director of said City, be and the same is hereby approved.

That the expenditure of \$378,844 from the Capital Outlay Fund 245 is hereby authorized solely and exclusively to provide funds for the purchase of the above described property.

That the City Clerk is hereby authorized and directed to file the foregoing said deed for record in the office of the Recorder of San Diego County.
