BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and directed to waive The City of San Diego's eligibility for \$15,000 in planning revenue available under the Omnibus Crime Control Act of 1973.

BE IT FURTHER RESOLVED, that such revenue be passed through to the San Diego Regional Criminal Justice Planning Board to be used for the purpose of improving the coordination of criminal justice planning between The City of San Diego, County of San Diego and the Regional Criminal Justice Planning Board.
