That the City Manager be, and he is hereby authorized and empowered, for and on behalf of said City, to execute an agreement with the NEIGHBORHOOD HOUSE ASSOCIATION (NHA) to conduct the Youth Service Center Project awarded to the City by the California Council on Criminal Justice (CCCJ), pursuant to the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 748009.

BE IT FURTHER RESOLVED, that the expenditure of \$5,955 is hereby authorized out of General Fund 100, solely and exclusively for the above purpose, to satisfy the local cash match equivalent required as a condition of the grant award.
