


**RESOLUTION No. 211119**Adopted on JUL 18 1974

That the expenditure of \$1,536,261 from Capital Outlay Fund 245 and \$800,000 from Federal Revenue Sharing Fund No. 2384 is hereby authorized solely and exclusively for the purpose of providing funds for the City's contribution for improvements in San Diego Park District No. 12F (Tecolote Main Canyon) as more particularly described in Resolution of Intention No. 210795 and pursuant to the San Diego Park District Procedural Ordinance of 1969 and the Municipal Improvement Act of 1913.
