
RESOLUTION No. 211131

1. That the bid of \$39,749.00 by William Reynolds, an Individual, dba Wm. Reynolds Const. Co., for CONSTRUCTION OF VEHICLE FUEL FACILITIES FOR UNLEADED GAS in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 747285.
2. That the expenditure of \$46,000.00 is hereby authorized out of Capital Outlay Fund (Fund No. 245) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF VEHICLE FUEL FACILITIES FOR UNLEADED GAS in the City of San Diego and related costs.
