


**RESOLUTION No. 211151**Adopted on JUL 25 1974

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of MIRA MESA SHOPPING CENTER, a partnership, executed in favor of The City of San Diego, bearing date of May 10, 1974, conveying to said City easements for street, sewer and drain purposes affecting a portion of Lot 5 of Mira Mesa Shopping Center Unit No. 5 according to Map thereof No. 7233 filed March 15, 1972 in the office of the San Diego County Recorder, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed as Parcel 2 is hereby dedicated as and for a public street and the same is hereby named CAMINO RUIZ.

That the City Clerk of said City is hereby authorized and directed to file, upon acceptance by the City Manager, the foregoing said deed for record in the office of the Recorder of San Diego County.
