


RESOLUTION No. 211157Adopted on JUL 25 1974

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of the SAN DIEGO UNIFIED SCHOOL DISTRICT OF SAN DIEGO COUNTY, CALIFORNIA, executed in favor of The City of San Diego, bearing date of May 28, 1974, conveying to said City an easement for street and slope purposes affecting a portion of Section 31, Township 14 South, Range 2 West, S.B.B.M., as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed as Parcel 1 is hereby dedicated as and for a public street and the same is hereby named BLACK MOUNTAIN ROAD; and the land therein conveyed as Parcel 2 is hereby dedicated as and for a public street and the same is hereby named HILLERY DRIVE.

That the City Clerk of said City is hereby authorized and directed to file, upon acceptance by the City Manager, the foregoing said deed for record in the office of the Recorder of San Diego County.
