NAME	DEPARTMENT	AMO	UNT SUGGESTION
Bobby F. Goetschel	WATER UTILITIES DEPARTMENT	\$80	Ms. Goetschel was engaged in processing the forms and system involving contractor deposits for use of water meter spacers. She proposed a new, much simplified system to be handled at Chollas instead of at the New Services Section (OPS). This saves considerable clerical time in Water Utilities and in the Auditor's Office. Savings are estimated to be about \$800 per year.
Earl B. Kinsel	BUILDING INSPECTION DEPARTMENT	\$50	Mr. Kinsel, an Intermediate Typist, suggested a revision in the Weekly Building Report Data Sheet that both reduces the clerical time for preparing it and Data Processing cost for producing the monthly Report of Building Permits Issued. This saves an estimated total of \$492 per year.
Alison M. McCullough	GENERAL SERVICES DEPARTMENT Sanitation Division	\$40	Ms. McCullough, an Intermediate Stenographer, discovered that a clerical record being made was a duplication of information available elsewhere. The elimination of this activity saves \$391 per year of clerical time.
Mark J. Tiedeman	WATER UTILITIES DEPARTMENT	\$25	Mr. Tiedeman observed that a heavy power agitator on a carbon storage tank was running continuously after it became empty. He suggested shutting this down until needed again. During a 77 day period, \$231 worth of electrical power was saved.
Charles R. W. Black	WATER UTILITIES DEPARTMENT	\$25	Mr. Black, an Engineering Trainee, designed a rotary calculator that greatly speeds up making conversions from Fairchild to the Lambert Coordinate System, or vice versa. This saves \$257 per year worth of time in the Maps & Records Section. It may have use in other departments.
