

RESOLUTION NO, 211174 JUL 25 1974 R. 75-109

APPROVING MAP OF TORREY KNOLLS PARK SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed by O. B. SHOLDERS, a Registered Civil Engineer, entitled "TORREY KNOLLS PARK Being a subdivision of a portion of Acre Lot 14 of Sorrento Lands and Townsite, according to Map thereof No. 483, filed in the office of County Record of San Diego County, February 9, 1888, portions of Lots 13 & 14 in Block 11, according to Map thereof No. 109, filed in the office of County Recorder of San Diego County on September 3, 1887, also Blocks 9 & 10, according to Map thereof Nos. 362 & 483, and portions of the aforementioned Block 11, as vacated by Superior Court Case No. 87450, together with Jasmine Street, Iris Street, Sorrento Valley Road, alleys, and portions of Lily Street, Kale Street and Kochia Street as closed and vacated to public use, all in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Sorrento Valley Road for public purposes, and said street is hereby declared to be a public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby rejects as a dedication that portion of Lot 2, marked "Reserved for Future Street," as shown on this map, under the provisions of Section 11616 of the Business and Professions Code.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the installation and maintenance of sewer and drainage facilities, and slopes, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said street is accepted on behalf of the public as heretofore stated; and that those certain easements for sewer and drainage facilities, and slopes, as granted and shown on this map are accepted on behalf of The City of San Diego, as above stated; and said Council has rejected that portion of Lot 2, marked "Reserved for Future Street," shown on this map, all as above stated.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
