WHEREAS, the Community Development Department of The City of San Diego has requested that the City quitclaim to C C & F MIRAMAR PROPERTIES, INC., a California corporation, its interest in and to said easement to allow better utilization of the property; and

WHEREAS, said easement is not needed for any present or prospective City use; and

WHEREAS, the value of the property right sought, as determined by a staff appraiser of said City, is the sum of sixty dollars (\$60); and

WHEREAS, no real estate broker's commission shall be paid; and

WHEREAS, the sale of the aforementioned property right is consistent with the public interest; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That that certain real property described in that form of quitclaim deed on file in the office of the City Clerk as Document No. 748147, be, and the same is hereby authorized to be sold by negotiation for the sum of sixty dollars (\$60) to C C & F MIRAMAR PROPERTIES, INC., a California corporation.
- 3. That no broker's commission shall be paid by City on the herein-described negotiated sale.
- 4. That the City Clerk of said City is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
